NOTICE OF RACE

Amendment N°1 – 5.1 - 5.2





[NP] Denotes a rule that will not be grounds for a protest by a boat. This changes RRS 60.1(a).

[SP] Indicates a rule in which the Race Committee or the Technical Committee may apply a standard penalty without a hearing or a discretionary penalty applied by the International Jury with a hearing. This modifies RRS 60.5(b)(3) and A5.

[DP] Indicates a discretionary penalty by the International Jury, which may range from 0 points to DNE.

1. RULES

- 1.1. The rules as defined in the World Sailing Racing Rules of Sailing (RRS) 2025 – 2028.
- 1.2. The prescriptions of the national authority will not apply.
- 1.3. Class rules regarding measurement will apply. Class rules related to the conditions for organizing and conducting class championships or requirements to be a class member will not apply.
- 1.4. Appendix P of the RRS, Special Procedures for Rule 42, will apply with the following modification: P2.3 is deleted, and P2.2 will apply to all penalties after the first infringement.
- 1.5. The official language of this championship will be Spanish. In case of discrepancies between documents, the original language of the corresponding document will prevail.
- 1.6. In case of discrepancies between the Notice of Race (NoR) and the Sailing Instructions (SI), the SI will prevail. This modifies RRS 63.5(c).
- 1.7. RRS 90.3(e) applies.
- 1.8. For Windsurfing events, Appendix B of the RRS applies, except for RRS B8.A8.

2. [DP] IDENTIFICATION AND ADVERTISING

- 2.1. When provided by the Organizing Authority, boats or competitors must carry, display, or wear the following as instructed:
 - a) Bibs for all competitors;
 - b) Colored bibs for the event leaders (1st, 2nd, 3rd);
 - c) Colored marks on the mainsail for the leaders of each event (1st, 2nd, 3rd);
 - d) Bow number;
 - e) Event advertising;
 - f) Cameras and sound equipment.

3. NOTICES TO COMPETITORS

3.5. Except in an emergency, no boat shall make radio or data transmissions while racing, nor receive radio, cell phone, or data communications that other boats cannot receive.

4. CHANGES TO THE NOTICE OF RACE

4.1. This Notice of Race may be subject to modifications, which will be published on the website of the Chilean National Sailing Federation www.fedevela.cl and on the Official Notice Board (ONB – TOA)

5.2. Categories are restricted to competitors who are younger than the age indicated for each event category. The U19 category is for sailors born after December 31, 2006, and the U23 category is for sailors born after December 31, 2002. These are the categories defined for the Youth Worlds Vilamoura 2025 (U19) and the Junior Pan American Games Asunción 2025 (U23).

6. ELIGIBILITY AND REGISTRATION

- 6.1. The championship is open to all sailors who can provide their own boat and who are members of an MNA affiliated with the South American Sailing Confederation. Competitors from other National Authorities (MNA) may also be accepted.
- 6.2. **WORLD SAILING (WS) eligibility requirements will apply.** Each competitor must be registered as a WS Sailor on the WS website.
- 6.3. Pre-registration will be conducted through the respective National Authority (MNA), allocating one representative per country for each sub-category listed in **section 3.1**.
- 6.4. The Organizing Authority will ensure the availability of a charter boat for each representative per country, according to the quota defined in **section 5.2**. Chartering will not be guaranteed for the **29er, Snipe, 420, and iQFoil** classes.
- 6.5. The Organizing Authority may expand the pre-registration quota per country depending on boat availability.
- 6.6. Registrations will be processed by completing the form available at www.fedevela.cl.
- 6.7. Registration payment must be made via electronic transfer to Fedevela national or international account.

CONSENT FORM FOR MINORS

Each sailor under 18 years old on **December 4, 2025**, must bring a completed parental/guardian consent form at registration. The form can be found in **Appendix A**. During the championship, the responsible adult named in the parental/guardian consent form will supervise each sailor under 18.

7. BOATS AND EQUIPMENT

- 7.1. Rental boats available after pre-registration will be assigned on a first-come, first-served basis. **iQ Foil equipment will not be available for charter.**
- 7.2. The Organization may provide contact details of local boat owners if additional rentals are needed.

8. ACCREDITATION

- 8.1. Competitors, coaches, team leaders, and support personnel must confirm their registration at the **Race Office** on **November 11, 2025**.

9.1. On **November 15**, no warning signal will be given after **16:00 hrs**.

9.2. All boats (including support boats) must be at the venue before **18:00 hrs on November 11, 2024**.

10. MEASUREMENT (DP, NP)

- 10.1. Each boat must have a valid measurement certificate, where applicable.
- 10.2. Information regarding equipment inspection will be published on the ONB.

11. SAILING INSTRUCTIONS

- 11.1. The sailing instructions will be available on the **ONB** before the registration deadline.

12. RACING AREAS

- 12.1. The races will be held in **CONCON Bay**.
- 12.2. The event venue is **Club de Yates Higuierillas**.

13. COURSE

- 13.1. The course will be defined in the **Sailing Instructions**.

14. PENALTY SYSTEM

- 14.1. The penalty system will be defined in the **Sailing Instructions**.



15. SCORING AND VALIDITY

- 15.1. The competition will consist of a single series for all events/classes.
- 15.2. The number of races, maximum races per day, and discards will be as follows:

The championship will be valid for each class with a minimum of **3 completed races**.

16. PRIZES

The top **three competitors** in each subcategory defined in **NOR 5.1** will be awarded.

17. SUPPORT BOATS

- 17.1. Support boats must be marked with the required identification, which will be specified in the **Sailing Instructions (DP)**.
- 17.2. Each support boat must carry a **VHF radio** capable of transmitting and receiving all international boat-to-boat channels. All persons on board must wear a **properly secured personal flotation device** at all times while afloat, except when briefly changing or adjusting clothing or personal equipment.
- 17.3. The **exclusion zone for support boats** will be detailed in the **Sailing Instructions**.

18. RESTRICTED AREA

- 18.1. All boats participating in the **South American Youth Championship** must remain at the **championship venue** from **November 11** until the end of the event.



19. DISCLAIMER OF LIABILITY

- 19.1. Competitors participate in the regatta **at their own risk**. See **RRS 3 – Decision to Race**. The organizing authority **will not accept liability** for material damage, personal injury, or death sustained **before, during, or after the regatta**.
- 19.2. Competitors must maintain their boats in a **safe and seaworthy condition**.
- 19.3. The **Notice of Race** and **Sailing Instructions** in no way limit or reduce the **complete and unlimited responsibilities of competitors**, who are solely and entirely responsible for the management of their boats before, during, and after the championship.
- 19.4. A competitor must be **in good health** and a **competent sailor**, capable of sailing in **open waters under all conditions**, including strong winds.
- 19.5. Incidents caused by **other boats are the competitor's responsibility**. Competitors are **not covered** by any liability insurance provided by the organizing authority and must obtain their own **personal property and liability coverage**. The organizing authority **recommends** that competitors check with their own insurance providers to ensure they are covered for this event, including additional personal liability insurance.
- 19.6. To the maximum extent permitted by law, each competitor agrees to **indemnify the Host, owners, affiliates, officers, employees, agents, members, volunteers, committee personnel, and race officials**, acting in their official capacities, from any claims arising from **a competitor's liability, acts, or omissions**.

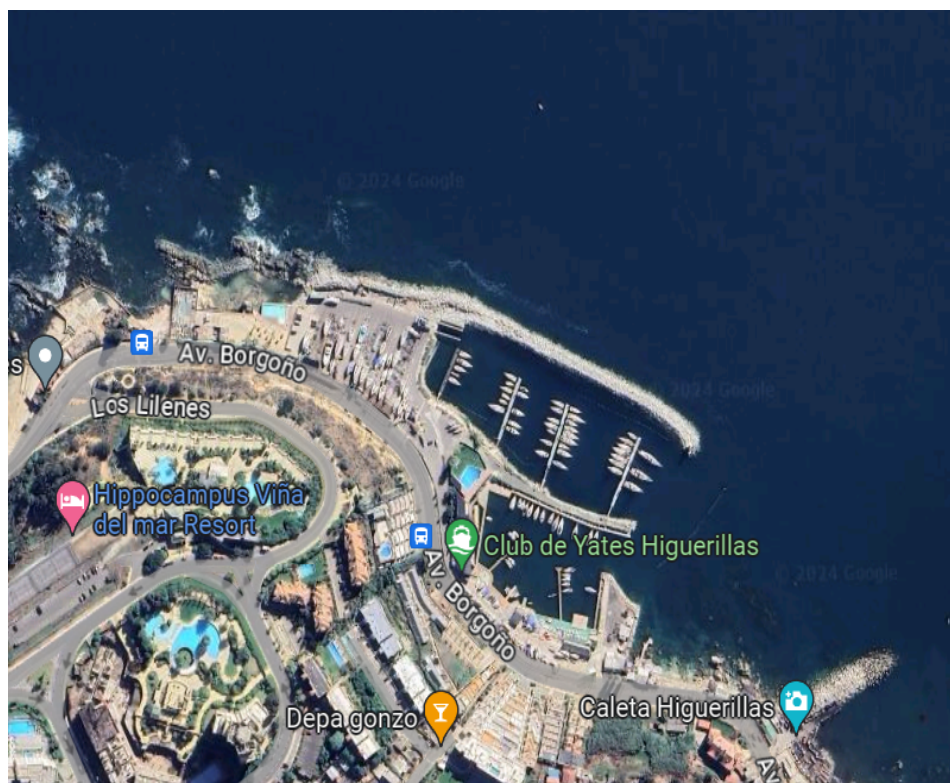

Brief Description & Surroundings

Concón is a coastal city in central Chile, located in the **Valparaíso region**. Along with **Valparaíso, Viña del Mar, Quilpué, and Villa Alemana**, it forms part of the **Greater Valparaíso Metropolitan Area**, being the **least populated city** in the region.

Among its **notable beaches**, "La Boca" stands out as a **popular surfing spot**, near the **mouth of the Aconcagua River**. Along the coast, visitors can find the **calmer waters** of "Playa Amarilla" and "Playa Negra," known for its **dark sand**.

Concón is **famous for its diverse seaside restaurants and natural attractions**, such as:

- **Concón Sand Dunes** – A protected natural sanctuary and a popular tourist attraction.
- **Aconcagua River Wetlands** – Home to a rich variety of native flora and fauna.
- **Roca Oceánica** – A rocky coastal formation that serves as a habitat for birds and offers scenic ocean views.

Since the 1990s, the city has experienced **significant urban and demographic growth**, with **high-quality residential areas** like **Bosques de Montemar**.
